Subject: Notification of disclosure and transfer of personal data in connection with the entire business transfer from Krungsri Securities Capital Public Company Limited to Krungsri Securities Public Company Limited

Dear Valued Customers of Krungsri Securities Capital Public Company Limited

Krungsri Securities Capital Public Company Limited (**KCS**), and Krungsri Securities Public Company Limited (**KSS**) recognize the importance of personal data protection and respects your privacy rights. We write to inform you of KCS's intention to disclose and transfer your personal data to KSS, and KSS's intention to collect, use and disclose your personal data in accordance with the requirements under the Personal Data Protection Act B.E. 2562 (the **PDPA**). Your personal data will be disclosed and transferred to KSS after the shareholders' meetings of KCS and KSS pass the resolution to approve the Business Integration (as defined below).

Background

Due to the reorganization of securities business of Bank of Ayudhya's financial group, KCS and KSS are working together to achieve a successful business integration by way of the entire business transfer (**EBT**) from KCS to KSS (**the Business Integration**). In this regard, we expect to complete the Business Integration successfully on 7 May 2024 or other date where you will be further informed of such (**the Transfer Date**).

On the Transfer Date, KCS will transfer and novate to KSS all of its rights and obligations in respect of all present and future agreements and transactions between you and KCS, and KCS will cease all of its operations from the Transfer Date onwards. Whereas you would be able to contact and transact products and services with KSS continuously, and seamlessly, from the Completion of Transfer Date as well.
